

SLO Regional Rideshare, a division of the San Luis Obispo Council of Governments (SLOCOG/Rideshare), is soliciting proposals from qualified entities to provide Safe Routes to School (SRTS) learn-by-doing, on-bike education and encouragement.

# SLOCOG/RIDESHARE AGENCY OVERVIEW

SLOCOG/Rideshare is a multi-disciplinary work group positioned as the region's one-stop-shop for transportation information. SLOCOG/Rideshare's primary role is to reduce reliance on Single Occupancy Vehicles (SOV) within the region (which covers the entire County of San Luis Obispo and commuter inter-county travels to/from adjacent counties). This multi-faceted group conducts outreach, marketing, and programs meant to increase public awareness, support, participation, and use of alternative transportation. We support all transportation needs of the community, including: youth, able-bodied adults and children, those persons with limited mobility, individuals of low income, and seniors.

Our programs include:

- Safe Routes to School (SRTS): cycling and walking advocacy for elementary through high school students
- Back 'N' Forth Club: employer and commuter focused outreach and support, including Regional Vanpool Subsidy and Guaranteed Ride Home offerings
- Know How to GO!: outreach, education, and travel training to increase mobility for monolingual Spanish speakers, persons with limited mobility, individuals of low income, and seniors
- SLO 511: telephone and online services for up-to-date information on road conditions, public transportation, specialized services, ridesharing, and much more

Our annual campaigns include:

- Rideshare Week (October), including Walk to School Day
- Bike Month (May), including Bike to School Day
- Youth Ride Free (available during summer months, when school is out)

Our core outcomes include:

- Creating an environment for people to easily access transportation information
- Developing incentives to encourage people not to drive alone
- Reducing barriers to using alternative transportation
- Providing transportation information in more convenient and useful formats
- Developing materials for target audiences and geographic areas
- Participating in community events
- Conducting and presenting extensive research
- Developing programs that target specific audiences

# **PROGRAM DESCRIPTION**

The learn-by-doing Safe Routes to School (SRTS) program consists of in-class education, including on-bike instruction, during physical education classes and "train-the-trainer" programs to create a sustainable program at additional schools for the future. As part of this outreach, bikes will be provided at no cost to students. The Safe Routes to School program will be offered at ten (10) regionally identified disadvantaged schools located throughout San Luis Obispo (SLO) County. Ten (10) additional "self-selecting" schools will also have access to "train-the-trainer" programs so that educators can learn about the program and teach it at their schools. This will train educators to teach the curriculum, analyze active transportation conditions and support active transportation activities at their own schools.

The San Luis Obispo Council of Governments (SLOCOG) has been awarded grant funding from the State of California for implementation of the Active Transportation Program (ATP) Safe Routes to School Non-Infrastructure projects for three years. The Safe Routes to School Non-Infrastructure Program (hereinafter will be referred to as "Program") will provide kinesthetic, active transportation education and encouragement to 4<sup>th</sup> and 5<sup>th</sup> grade students in their physical education class environment. The Program will teach students how to safely navigate the road, promote increased independence, and enhance public health.

Another challenge addressed in this Program is increasing awareness for concerned parents. Parents and their children lack mobility because they are not educated about navigating as a pedestrian or bicyclist, particularly where there is a physical barrier. The Program seeks to make parents and students more aware of the environment through walkability and bikeability audits of routes to school. Understanding the barriers and how to safely navigate them is a main theme of the project. The Program further encourages students by giving them an "active transportation license."

The 2014 Regional Transportation Plan (RTP) defined disadvantaged communities (2014 RTP-SCS Amend 1 Chapter 2). The method for identifying disadvantaged communities was based on a wide variety of characteristics, including median home income, free and reduced priced meals, and many more characteristics. For this project, ten (10) disadvantaged schools were selected based on their proximity to disadvantaged communities. This three (3)-year Program will include learn-by-doing, on-bike education and encouragement at the following elementary schools:

- Grover Beach Elementary School
- Nipomo Elementary School
- Oceano Elementary School
- Lillian Larsen
- Bauer/Speck Elementary School
- Santa Rosa Road Academic Academy
- Hawthorne Elementary School
- Georgia Brown Elementary School
- Baywood Elementary School
- C.L. Smith Elementary School

A complete profile for each target school is included in Appendix F for reference.

# **PROGRAM GOALS & OBJECTIVES**

#### Goals

Primary goals for the Program are:

- 1. Increase active transportation throughout SLO County.
- 2. Increase student and family knowledge of how to safely navigate the road.
- 3. Reduce overall congestion on the road.
- 4. Enhance public health by reducing obesity, creating a better sense of community and improving air quality and safety around schools.
- 5. Leverage available federal, state and local funds to maximize long-term potential for Safe Routes to School in SLO County.

### Objectives

Primary objectives for the Program are:

- 1. Refine existing Active Transportation Resource Center's (ATRC) curriculum to fit the needs of our local students.
- 2. Coordinate and manage the SRTS Task Force, which includes a diverse set of stakeholders.
- 3. Offer learn-by-doing, on-bike education to 4<sup>th</sup> and 5<sup>th</sup> grade students at ten (10) schools located in disadvantages communities.
- 4. Train educators at ten (10) additional schools to analyze active transportation conditions and support active transportation activities coordinated by school champions.

Proposals must be received **no later than 12:00 p.m. on Wednesday, September 4, 2019**. If mail delivery is used, the proposer should mail the proposal early enough to provide for arrival by this deadline. Proposer uses mail or courier service at his/her own risk. SLOCOG/Rideshare will not be liable or responsible for any late delivery of proposals. *Postmarks will not be accepted.* 

The proposals shall be held in confidence and shall not be available for public review. No proposal shall be returned after the date and time set for opening thereof. Refer to "Evaluation Criteria" for more details regarding the evaluation committee and the selection process.

# SCOPE OF WORK/SERVICES

In San Luis Obispo County, walking/biking to school is marginal compared to commutes by vehicle. Seventy-one percent (71%) of students are driven to school because parents are concerned about the safety of their children and feel uncomfortable allowing them to walk or ride a bike. Some parent concern is warranted due to the number of crashes near schools in the county. To overcome these concerns and to provide health, educational performance, and social benefits to student, the Program is proposed. The Program will occur over the 2019/2020, 2020/2021 and 2021/2022 school years and will consist of the following:

# Task A: Continue Formulating SLO County Safe Routes to School Pedestrian and Bicycle Safety Curriculum (5pts)

The consultant is to become familiar with ATRC curriculum and to continue customizing the curriculum for each of the ten (10) schools (i.e., using street names and knowing the area surrounding the school). Additionally, the consultant is to procure teaching equipment needed for new curriculum.

Respondents shall describe:

- What equipment will be obtained and used.
- Where the equipment will be obtained from and where the equipment will be stored.
- Availability of transportation to transport equipment.

Deliverables:

• Furnished equipment, such as the required thirty (30) bicycles, truck and bike trailer.

#### Task B: Administration and Program Management (5pts)

The consultant is to work closely with the Rideshare Programs Coordinator to schedule assemblies, on-bike education and bike rodeos.

Respondents shall identify:

- Primary point of contact for scheduling tasks.
- Secondary point of contact in case primary point of contact is unavailable.
- Availability of both staff contacts.

Deliverables:

• Learn-by-doing active transportation assemblies, on-bike education and bike rodeos.

#### Task C: Learn-By-Doing On-Bike Education (10pts)

The consultant is to work with school staff to: implement ATRC curriculum during in-classroom and on-bike sessions, and keep parents/guardians informed about active transportation SRTS Program.

Respondents shall describe how they will:

- Communicate with school staff to implement ATRC curriculum.
  - Response shall include capability to work directly with ten (10) schools and indirectly with an additional ten (10) schools as part of the train-the-trainer initiative.
- Teach students for both in-classroom and on-bike sessions.
- Inform parents/guardians about the Program.
- Ensure that the bikes are well maintained.
  - Describe how repairs will be scheduled, managed and related costs covered.
- Provide maintenance and where the maintenance facilities will be located.
- Provide spare bikes as needed and at what cost.

Deliverables:

- Curriculum for ten (10) Program schools
- Train-the-trainer tools and services for an additional ten (10) schools
- Student examples, pictures, and/or progress reports
- Maintained fleet of bikes

#### Task D: Active Transportation Encouragement & Engagement (10pts)

The consultant is to work closely with the Rideshare Programs Coordinator to continue recruiting SRTS Champions at all county schools. This outreach will include one-to-one meetings to deliver and orient champions with existing bikeability/walkability maps. Consultant will also organize and host thirty (30) Walk to School Days and thirty (30) Bike to School Days for schools countywide. The consultant will also host ten (10) bike rodeos at identified schools. Respondents shall describe how they will:

- Recruit new SRTS Champions.
- Consolidate current champions using existing bikeability/walkability maps.
- Coordinate with Rideshare Programs Coordinator and Champions to host events.
- Perform bicycle and pedestrian counts at ten (10) identified schools.

Deliverables:

- SRTS Champions
- Delivered bikeability/walkability maps
- Walk to School Day
- Bike to School Day
- Bike rodeos

## **REQUIRED ELEMENTS IN RESPONSE FORMAT**

Firms, teams, or individuals responding to this solicitation shall provide the following information in their proposals in the order listed below. Only complete submittals will be evaluated. All submittals must be delivered electronically via either email, standard file sharing service (i.e.: DropBox) or flash drive.

#### Cover Letter

Respondents should submit a cover letter expressing their interest in the Program. The letter must contain, at a minimum, the following information:

- a) Statement of interest referencing learn-by-doing SRTS Program.
- b) Certification that the information and data submitted is true and complete to the best knowledge of the individual signing the letter.
- c) Respondent's name, address, telephone number, fax number and e-mail address.
- d) Identical contact information for the individual to be responsible for the day-to-day oversight of the Program.
- e) An authorized principal or partner of a firm shall sign the letter.
- f) Identification of whether the prime respondent is certified as a Disadvantage Business Enterprise (DBE), or indication as to the respondent's goals for DBE participation, if any.

#### Qualifications and Experience of the Respondent

Respondents shall describe several on-bike education and encouragement projects and related experience of the past three years relevant to the draft scope of services described in Scope of Work/Services. Respondents should place particular emphasis on projects for which key staff to be assigned to this Program have either been primarily responsible or have performed substantial work. If subcontractors are to be used, the means by which these firms will participate must be specified and their experience and credentials presented in this section.

#### Qualifications and Experience of Key Staff

Respondents shall identify the key individuals to be assigned to this Program (by name and position) and describe the work tasks assigned to each individual. The respondent must also provide experience summaries of these key individuals, describing for each individual their previous experience on similar projects in similar roles, their educational background, and their length of tenure with the proposing firm or entity. Resumes of these key individuals may also be included, and can be added in the optional section; but they cannot substitute for the specific history or recent experience of the team members, as they directly relate to this proposal. Respondents shall also list any professional affiliations, licensures and certifications that are pertinent to the work described in Scope of Work/Services.

#### References

Respondents shall submit complete and current contact information for the identified references familiar with the respondent's ability, experience, and reliability in the performance and management of projects of a similar nature with the form found in Appendix E. A short narrative should give highlights on each of the projects used as a reference. A minimum of three different professional references for the lead person on the team should be submitted (as opposed to the firm in general), including: a) the current name of the client's agency or organization, b) the name of the professional contact (including their title, current e-mail, and phone number and c) the start and end times of the working relationship.

#### **Cost Information**

Respondents shall provide cost information as requested in Scope of Work/Services. Costs are not to exceed the awarded amount of \$75,000 for this three-year program.

#### Project Management and Scheduling Expertise

Respondents shall identify the management techniques that they are using to assure the completion of projects within schedule and budget as requested in Scope of Work/Services.

#### **Insurance Requirements**

Respondents shall provide information regarding the types of insurance carried, specifically in the areas of general liability, professional liability, automotive and workmen's compensation. Indicate the limits of coverage on each policy. Said insurance will be required to be maintained in full force and effect during the term of the contract(s).

All insurance policies required hereunder shall include clauses stating that each carrier shall waive all rights of recovery, under subrogation or otherwise, against SLOCOG/Rideshare its agencies, institutions, organizations, officers, agents, employees, and volunteers.

The foregoing insurance types, limits, and coverages may be modified only with the express written consent of SLOCOG/Rideshare and shall be subject to additional terms and conditions of any contract(s) awarded pursuant to this RFP.

Additional Forms Disadvantaged Business Enterprise Information and Affidavit of Non-Collusion All Respondents shall complete and return the Disadvantaged Business Enterprise Information Request Form (Appendix A), Affidavit of Non-Collusion (Appendix B), Public Contract Code (Appendix C), and Insurance Requirement Form (Appendix D).

# **EVALUATION CRITERIA**

Proposers may be telephoned and asked for further information, if necessary, and will be expected to appear for verbal, in-person interviews, as determined after the technical evaluation and reference checks. Previous clients will also be called.

An independent panel will make recommendations to SLOCOG/Rideshare staff on the basis of the proposer's technical evaluation, oral interview and reference checks.

SLOCOG/Rideshare reserves the right to select a consultant based solely on written proposals and telephone interviews, and not convene oral interviews.

Upon receipt of the proposals, a technical evaluation will be performed. Each of the written proposals will be reviewed and evaluated with criteria designed to help judge the quality of the proposals (total of 100 points possible). Evaluation criteria will include such considerations as:

#### **Conflict of Interest**

Respondent shall not engage in any business, personal activities, practices, or maintain any relationships which conflict in any way with the full performance of respondent's obligations in this Program. After SLOCOG/Rideshare's prior written approval, respondent shall refrain from any practices, activities or relationships that reasonably appear to be in conflict with the full performance of respondent's obligations to SLOCOG/Rideshare. If a conflict or appearance exists, or if respondent is uncertain whether a conflict or the appearance of a conflict of interest exists, respondent shall submit to SLOCOG/Rideshare a disclosure statement setting forth the relevant details for SLOCOG/Rideshare's consideration. Failure to promptly submit a disclosure statement or to follow SLOCOG/Rideshare's direction in regard to the apparent conflict will constitute a breach of contract.

#### **Federal and State Requirements**

Such policy shall contain a Waiver of Subrogation endorsement in favor of SLOCOG. Such Workers Compensation & Employers Liability may be waived, if, and only for as long as, the selected consultant is a sole proprietor with no employees.
	<u>Commercial General Liability Insurance</u> for Bodily Injury and Property Damage liability, covering the operations of the selected consultant and its officers, agents, and employees and with limits of liability which shall not be less than <b>\$1,000,000</b> combined single limit per occurrence with a general aggregate liability of not less than <b>\$2,000,000</b> , and Personal & Advertising Injury liability with a limit of not less than <b>\$1,000,000</b> . Expense for Indemnitee's defense costs shall be outside of policy limits and such policy shall be issued on a Duty to Defend Primary Occurrence Form.
	SLOCOG and their respective commissioners, directors, officers, representatives, agents and employees are to be named as additional insured. Such insurance as afforded by this endorsement shall be primary as respects any claims, losses or liability arising directly or indirectly from the seleced consultant's operations.
	Errors and Omissions Professional Liability Insurance in an amount no less than \$2,000,000. If such policy is written on a "Claims-Made" (rather than an "occurrence") basis, proposer agrees to maintain continuous coverage in effect from the date of the commencement of services to at least three (3) years beyond the termination or completion of services or until expiration of any applicable statute of limitations, whichever is longer. The policy shall provide coverage for all work performed by the selected consultant and any work performed or conducted by any subconsultant working for or performing services on behalf of the proposer. No contract or contract between the selected consultant and any subconsultant shall relieve the consultant of the responsibility for providing this Errors & Omissions or Professional Liability coverage for all work performed by the consultant and any subconsultant working on behalf of the consultant on the project.
	Business Automobile Insurance for all automobiles owned, used or maintained by proposer and proposer's officers, agents and employees, including but not limited to owned, leased, non- owned and hired automobiles, with limits of liability which shall not be less than \$1,000,000 combined single limit per occurrence.
	<u>Umbrella Insurance</u> in the amount of \$1,000,000 providing excess limits over Employer's Liability, Automobile Liability, and Commercial General Liability Insurance.

**Deductibles:** Any deductibles or self-insurance retentions over **\$50,000** are subject to the approval of SLOCOG.

**Notice of Termination:** All policies shall provide that the insurance carrier shall give written notice to SLOCOG at least 30 days prior to cancellation, non-renewal or material change of coverage in the policy or policies, and shall provide notice of such change to SLOCOG and any other additional insured.

Additional Provisions: Each policy or policies of insurance described in <u>Commercial General Liability</u> Insurance, above shall include an endorsement providing that such insurance is primary insurance and no insurance of SLOCOG will be called on to contribute to a loss.

**Certificates of Insurance:** Promptly on execution of this Contract and prior to commencement of any work hereunder, the consultant shall deliver to SLOCOG Certificates of Insurance verifying the aforementioned coverages. Such certificates shall make reference to all provisions and endorsements referred to above and shall be signed on behalf of the insurer by an authorized representative thereof. Proposer agrees, upon written request by SLOCOG, to furnish copies of such policies or endorsements required under the Contract prior to the Effective Date of the Contract.

**Disclaimer:** The foregoing requirements as to the types of limits of insurance coverage to be maintained by consultant are not intended to and shall not in any manner limit or qualify the liabilities and obligations otherwise assumed by consultant pursuant hereto, including, but not limited to, liability assumed pursuant to indemnification.

**Subconsultant/subcontractor's Insurance:** The Consultant shall require each of its subconsultant/subcontractors to provide the aforementioned coverages, unless such coverages are waived or reduced in writing by the SLOCOG Executive Director.
